The effective date and expiry of each individual price are separately specified. Where applicable, tables indicate the time frame for which a rate is valid with “effective from” and “effective to” dates shown.

The RIO Price List is published on the BT Ireland website.

This list contains details of the services detailed in Annex A of the BT Reference Interconnect Offer, an index of which is included below.

Prices may vary from time to time. Changes to these prices shall be construed to be automatically part of all Reference Interconnect Offer agreements with immediate effect from the date set by the National Regulator.

The charges relevant to each service are listed in euro or euro cent. Traffic charging for each service shall be based on chargeable cumulative seconds for each Billing period rounded to the nearest minute per call charges unless otherwise stated.

This pricing schedule takes account of two part charging, where the following terminology is used:

- Charge per Call (also known as the call set up charge)
- Cost per minute (also known as the call duration charge)

For call-related services, prices are shown to 4 decimal points. All other services are shown in euro to the nearest euro cent.

BTI reserves the right to raise a balancing surcharge on origination charges where the interconnecting Operator applies an unreasonable termination charge on traffic passed to the Operator for termination.

BTI reserves the right to recover costs where the Operator will not or cannot accept calls into the Operator’s network and BT must transit such calls via a transit operator.

¹ Where charges for calls to BT numbers are passed in with higher than the specified threshold, BT will apply the following ladder pricing surcharge in addition to the per-minute BT termination rate:

Surcharge per minute = (incoming cost/total minutes) - Surcharge Threshold

Example 1: Operator passes call to BT0818 for termination and charges BT €0.0055 per minute. BT will charge 0818 termination at the per-minute rate of $(€0.00057 + (€0.0055-0)) = 0.62c$ per minute.

Example 2: Operator passes call from fixed subscriber to BT1800 and charges BT €0.021 per minute. BT will charge 1800 termination to that operator at the per-minute rate of $(€0.00 + (€0.021-€0.00873)) = 1.227c$ per minute
